ORDINANCE NO. 385

AN ORDINANCE AMENDING CHAPTER 65, SECTIONS 65.02 AND 65.04 OF THE CODE OF ORDINANCES OF THE CITY OF HULL BY DESIGNATING AN ADDITIONAL SPECIAL STOP AND YIELD INTERSECTIONS.

BE IT ORDAINED by the City Council of the City of Hull, Iowa:

Section 1. Section 65.02 is hereby amended by striking the entirety of the following subsections, making no replacement, and renumbering the remaining subsections thereafter: 11

Section 2. Section 65.02 is hereby amended by adding thereto the following new subsections:

- 15. Railroad Street. Vehicles traveling west on Railroad Street shall stop at Hayes Street.
- 16. Seventh Street. Vehicles traveling east on Seventh Street shall stop at Maple Street.
- 17. Thirteenth Street. Vehicles traveling on Thirteenth Street shall stop at Maple Street.
- 18. Birch Street/Third Street. Vehicles traveling on Birch Street shall stop at Third Street and vehicles traveling east on Third Street shall stop at Birch Street during the hours of operation of the municipal pool when a stop sign is present in the intersection.

Section 3. Section 65.04 is hereby amended by striking the entirety of the following subsections, making no replacement, and renumbering the remaining subsections thereafter: 13, 16

Section 4. Section 65.04 is hereby amended by adding thereto the following new subsections:

- 24. Railroad Street. Vehicles traveling on Railroad Street shall yield at Chestnut Street.
- 25. Railroad Street. Vehicles traveling on Railroad Street shall yield at Brown Street.
- 26. First Street. Vehicles traveling on First Street shall yield at Brown Street.
- 27. Third Street. Vehicles traveling on Third Street shall yield at Brown Street.
- 28. Third Street. Vehicles traveling on Third Street shall yield at Birch Street.
- 29. Center Street. Vehicles traveling on Center Street shall yield at Brown Street.
- 30. Fourth Street. Vehicles traveling on Fourth Street shall yield at Chestnut Street.
- 31. Fifth Street. Vehicles traveling on Fifth Street shall yield at Chestnut Street.
- 32. Seventh Street. Vehicles traveling on Seventh Street shall yield at Chestnut Street.

- 33. Birch Street. Vehicles traveling on Birch Street shall yield at Center Street.
- 34. Edith Street. Vehicles traveling on Edith Street shall yield at Center Street.
- 35. Edith Street. Vehicles traveling on Edith Street shall yield at First Street.
- 36. Edith Street. Vehicles traveling on Edith Street shall yield at Railroad Street.
- 37. Maple Street. Vehicles traveling on Maple Street shall yield at Fourth Street.
- 38. Walnut Street. Vehicles traveling on Walnut Street shall yield at Fifth Street.
- 39. Walnut Street. Vehicles traveling on Walnut Street shall yield at Fourth Street.
- 40. Walnut Street. Vehicles traveling on Walnut Street shall yield at Second Street.
- 41. Walnut Street. Vehicles traveling on Walnut Street shall yield at Railroad Street.
- 42. Elm Street. Vehicles traveling on Elm Street shall yield at Railroad Street.
- 43. Elm Street. Vehicles traveling on Elm Street shall yield at Second Street.
- 44. Elm Street. Vehicles traveling on Elm Street shall yield at Fourth Street.
- 45. Chestnut Street. Vehicles traveling on Chestnut Street shall yield at Eighth Street.

Section 5. Section 65.05 is hereby amended by striking the entirety of subsections 1 and 2, making no replacement, and renumbering the remaining subsections thereafter.

Section 6. Section 65.06 is hereby amended by striking subsections 1 and 2 in their entirety, and adding thereto the following new subsections:

- 1. No motorized vehicular traffic, except school buses, shall be allowed on First Street, between Locust Street and Division Street, at such time as "DO NOT ENTER" signs are placed at locations within that block in accordance herewith. Authorization to place portable signs so providing is granted to Boyden Hull School District for reasonable periods on school days during the loading and unloading of buses, or the departure of such buses from the school's premises, such periods not to exceed one hour for bus loading and unloading.
- 2. No motorized vehicular traffic, except school buses, shall be allowed on Fifth Street, between Chestnut Street and 200 feet west of Elm Street, at such time as "DO NOT ENTER" signs or cones are placed at locations within those blocks in accordance herewith. Authorization to place portable signs so providing is granted to Hull Christian School for reasonable periods on school days during the loading and unloading of buses, or the departure of such buses from the school's premises, such periods not to exceed one hour and thirty minutes for bus loading and unloading.

Section 7. <u>Repealer</u>. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 8. <u>Severability Clause</u>. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part hereof not adjudged invalid or unconstitutional.

Section 9. When Effective. This ordinance shall be in effect after its final passage, approval and publication as provided by law.
